It is the buyer's responsibility to promptly follow through with the final grading and landscaping and to maintain a positive slope away from the foundation (6" down for every 10' from the foundation), including refilling any settled, backfilled and trenched areas. Lack of proper maintenance may cause foundation failure that will not be covered by the Contractor's warranty.

Expenses incurred because of soil conditions such as quick sand, rock, trees, frost, including necessity for additional excavating, providing fill or cutting of lot, grading, removal of excess ground, additional footings, reinforcing, piers, additional depth of foundation wall, pumping, waterproofing of basement or diversion of water because of springs, wells, seepage, and underground drainage shall be paid by Buyer.
